To qualify schools must complete the attached application and ensure the following:

1. Application is complete and accurate.
2. Application has signature of Principal and witness.
3. Only one application per school.
4. The following criteria will be used to evaluate requests:
  - What are the benefits to the school and surrounding community?
  - What segment of the school's population will be impacted by this request?
  - What are the short and long term effects of this request?
  - Is this for basic educational needs or enrichment?

**Any school which has received funding through an LRSC Welfare request from August 2009 through July 2010 in an amount greater than \$500 is not eligible for an Educational Grant.**

Our organization is dedicated to actively supporting our community and its educational institutions. We would like to help make a difference in the quality of education for all children. **Applications must be postmarked by March 31, 2010.**
